

Result of National Overseas Scholarship (NOS) for SC etc. candidates for the Selection Year 2021-21 (2nd List)


During the second cycle of Selection for Selection Year, 2021-22, total 264 applications were received through NOS portal from the candidates between 1.9.2021 to 15.10.2021. All the applications have been considered and examined in the Department. The following has been approved by the competent authority:-

- i. 57 (Fifty seven) candidates have been **provisionally** selected for the Award (Annexure-I), which includes 17 vacant slots from 1st List who have withdrawn scholarship due to various reasons.
 - ii. A waiting list of 53 applicants (Annexure-II), in case, selected applicants withdraws scholarship in future in order to fill all 100 slots of current selection year. It is also necessary to state that all candidates, who are placed in waiting List, are placed as per QS rankings and it does not confer any right for final/future selection. They are suitably advised to apply afresh with all the requisite documents as per scheme guidelines in the next cycle through NOS Portal.
 - iii. 154 (One hundred and fifty four) applications have been rejected due to non-fulfilment of eligibility criteria/incomplete application. Rejected candidates may apply afresh with all the requisite documents as per scheme guidelines in the next cycle through NOS Portal (Annexure-III).
2. The candidature of the selected candidates is **PROVISIONAL** subject to being found eligible in all respects. The candidates would be required to produce the original certificates in support of their claims relating to age, educational qualifications, caste, income etc. before actual release of funds. They are, therefore, advised to keep the said certificates ready.
3. Provisional Award letters will be issued to selected candidates shortly. The selection would be confirmed subject to verification of all original documents and fulfilment of the other eligibility requirements like Police verification, Submission of Bonds, Confirmation of admission, accreditation of college/ university by Indian Missions abroad etc. as per scheme guidelines. The provisional Award letter however, will not bestow any legal right on the candidate to claim the award and the award will be cancelled if any information/ documents submitted by the candidate is found to be false/ incorrect.
