# Result of National Overseas Scholarship (NOS) for SC etc. candidates for the Selection Year 2020-21 (2nd Cycle)

During the 2nd Cycle of selection, 190 applications were received through NOS Portal nosmosje.gov.in from 1st July to 30 July 2020. Based on the submission of complete documents by the Applicants and recommendations of the Selection Committee 37 (thirty seven) candidates have been selected for grant of Scholarship on provisional basis by the Competent Authority. The details of the selected candidates are given at Annexure-I. 153 (one hundred and fifty three) applications have been rejected by the Competent Authority due to non-fulfillment of eligibility.
