Result of National Overseas Scholarship (NOS) for SC etc. candidates for the Selection Year 2021-22 (4th List)

Consequent upon withdrawal /closing of scholarship Cases of 6 awardees from Selection Year till 31st March , 2022 , the following has been approved by the competent authority:-

a) Applicants placed in **S.No 31 to S.No 36** in the Revised waiting list have been **provisionally** selected for the Award (Annexure-I), against the withdrawal/closing of scholarship of 6 awardees due to various reasons.

2. The candidature of the selected candidates is **PROVISIONAL** subject to being found eligible in all respects. The candidates would be required to produce the original certificates in support of their claims relating to age, educational qualifications, caste, income etc. after issuance of Provisional Award letter. They are, therefore, advised to keep the said original documents/certificates ready and may visit this Ministry by taking prior appointment/permission. The selection would be confirmed subject to verification of all original documents and fulfillment of the other eligibility requirements as per scheme guidelines.

3. Provisional Award letters will be issued to selected candidates shortly. The provisional Award letter however, will not bestow any legal right on the candidate to claim the award and the award will be cancelled if any information/ documents submitted by the candidate is found to be false/ incorrect he/she will be debarred from the award and if he/she has availed scholarship or is availing scholarship, action will be initiated for recovery of the scholarship disbursed as per the extant guidelines of the scheme. Such candidate is also liable to be black listed for future.

4. Waiting List of Selection Year 2021-22 was valid upto 31st March, 2022 and therefore, it shall be deemed as closed.
